No-Till Drill Rental Program

For rent to Rensselaer County residents from the District is our Haybuster 107c No-Till Drill. The district is proud to share that this program has provided service in benefiting many residents in the county in 2019. This equipment allows you to plant small grains, legumes, and grasses on your fields while saving the time, money, and labor costs associated with tillage operations. By switching to No-Till, you also help conserve and build soil organic matter, improve soil moisture, reduce soil erosion, reduce soil crusting, and potentially reduce the amount of fertilizer lost and needed each season due to improved soil conditions. For this program, we only ask that the district is named as an additional insured on your liability and property insurance for the specific piece of equipment.



2019 Stream Project

A successful stream stabilization project used with secured Part C Conservation Funds on a local farm in Grafton, NY. Once the stream work was completed by a contractor, all exposed soils were seeded and mulched by the SWCD staff.

2020 Cover Crop Program

The district secured funds for the upcoming year to offer a **Cover Crop Program** to local farmers within the county. The intent of this program is to aid in stabilizing highly erodible soils (HEL) and soil health by supplying free winter rye seed to farmers to apply across their fields in need during the year 2020.



Agricultural Environmental Management (AEM)

Agricultural Environmental Management (AEM) is a voluntary, incentive-based program that helps farmers make common-sense, cost-effective and science-based decisions to help meet business objectives while protecting and conserving natural resources. Farmers can work with local AEM resource professionals from the district to develop comprehensive farm plans using a 5 tiered process. Erosion and Sediment Control Training

A NYS DEC endorsed 4 hour Erosion and Sediment Control Training is available online. Under the SPDES General Permit for Stormwater Discharges from Construction Activity, certain contractors (Trained Contractor) and certain Qualified Inspectors are required to complete four hours of DEC-endorsed training in the principles and practices of erosion and sediment control (E&SC) every three years. To satisfy this training requirement, DEC has partnered with county Soil and Water Conservation Districts across the state to deliver a four-hour E&SC training course. In addition, DEC accepts the following training options as meeting the four-hour endorsed training requirement:

- The NYS Conservation District Employees' Association online version of the DEC endorsed four-hour E&SC course.
- The NYS Builders Association Online version of the DEC endorsed, four-hour E&SC course.
- The one-day "CPESC Exam Review Course" for those taking the CPESC exam.

School Seedling Program

The Colonel William F. Fox Memorial Saratoga Tree Nursery offers a free native shrubs and trees in their **School Seedlings Program** to schools and educational organizations. All schools located within New York State - public, private, nursery, elementary, secondary, vocational, college, university, and any youth education-based organization are eligible. Buffer in a Bag Program

Anyone who owns or manages at least 50 feet of land along a stream or waterbody in New York State is eligible to receive a **free bag** of native seedlings. Properties with 50-99 feet of streamside land are eligible for one bag, and properties with 100 or more feet are eligible to apply for two bags. Applicants must provide photos and information indicating where the trees will be planted. There is a limited supply and recipients are selected first-come, first-served. Trees for Tribs Program

The **Trees for Tribs Grant Program** supports efforts to reforest New York's tributaries that flow into and feed larger rivers and lakes. The goal of the program is to support communities in planting young native trees and shrubs along stream corridors to prevent erosion, increase flood water retention, improve wildlife and stream habitat, as well as protect water quality.

An eligible type of project are riparian tree plantings, consisting of planting native trees and shrubs along streams on public and private property improves wildlife habitat, water quality and climate and storm resiliency. Eligible activities include landowner outreach and education, planting plan development, site preparation, riparian planting (including native trees and shrubs, plant shipping costs, tree tubes, weed mats, stakes), equipment rentals, contractor and staff expenses. Eligible applicants include municipalities, academic institutions, and 501(c)(3) not-for-profit corporations and other groups such as unincorporated river associations whose projects are located within the eligible geographic boundaries defined in this Request For Applications, which can be found here: http://www.dec.ny.gov/animals/113412.html on the NYS DEC website.


1.5 Million Gallon Manure Storage Project
